<u>ORDER</u>

MAHARAJA AGRASEN VIDYALAYA, MEMNAGAR, AHMEDABAD, a Self Financed School management made the proposal under Rule-6 of Gujarat Self Financed Schools (Regulation of Fees) Rules – 2017, in Form - II before this Committee as per the provision of Rule – 7 of Gujarat Self Financed Schools (Regulation of fees) Rules – 2017.

The Meeting of the Fee Regulatory Committee is held today at 11:00 AM to consider proposals of 05 School for determination of their provisional fees for the year 2017-18. On Prima facie Scrutiny and perusal of all these proposals along with whatever documents and accounts attached there with, committee found that many of schools have not submitted their complete details and all relevant accounts and figures for the year 2015-16 and 2016-17 are missing in some of the cases. Fees proposed by many schools are exorbitant as compared to fees charged by them for earlier years. There appears to be systematic attempt on the part of school building, Transportation charges and other activity charges. In many cases, the School management is collecting Fees under different heads, Such as Transportation charges, Uniform charges, meal or food charges, activity charges Etc. If these are optional and students are free to choose, there may not be any problem. However, When they are made compulsory, the element of profit may not be ruled out.

Since the provisional Fees for each of these Schools are to be determined within time bound framework, it may not be possible to minutely examine all these details. This Exercise will be undertaken by the Committee after considering objections, If any, raised by any school against determination of provisional Fees by the committee. For the time being, the committee determines the provisional Fees for each of the schools in question for the year



2017-18 as under, and the same shall remain in force till the committee finally determines the Fees or it is altered, amended or modified by the Fees Revision committee or by Hon'ble Supreme Court, in appropriate proceedings.

Terms and Conditions.

- 1. It is made clear that no School is permitted to collect fees for the first quarter of 2018-19 more than the provisional fees determined for the year 2017-18 with 5% rise therein.
- 2. It is also made clear that no School is permitted to collect more fees for the remaining quarters of 2017-18, if any, more than provisional fees determined by this Committee and if any excess fees are collected by any of these schools the same shall have to be refunded to the students.
- 3. It is further made clear that no school is permitted to collect fees under any other head including under the head Admission fees or term fees and thereby causing any extra burden on the students.
- 4. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 5. This provisional fees determined by the Committee shall be subject to the final determination that may be made by the Committee, after considering the objections received by the committee, if any and as may be altered, amended or modified either by the Fees Revision Committee or by the Hon'ble Supreme Court of India in appropriate proceedings.
- 6. The Committee has considered the provisional Fees for the year 2017-18 with 5% rise therein for the year 2018-19 and 2019-20.



7. If any school is aggrieved by provisional fees determined by the committee, it shall raise an objection before the committee within 7 days from the date of receipt of this order.
