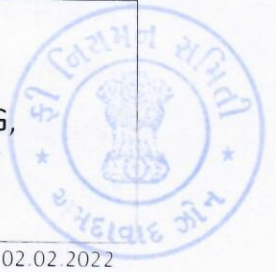

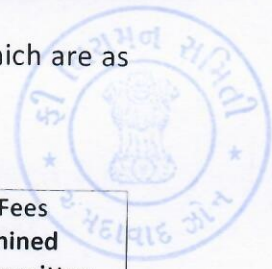

1. Maharaja Agrasen Vidyalaya, Near Sterling Hospital, Gurukul, Memnagar, Ahmedabad – 380 052, for the Academic Year : 2021-22 for Pre Primary and Primary Section Std. 1 to 8 (CBSE English Medium) along with relevant documents. After considering the said proposal and the documents attached therewith, the committee has passed the provisional order on 24.11.2021 for the academic

year : 2021-22 for Pre Primary and Primary Section Std. 1 to 8, Secondary, Higher Secondary (Commerce), Higher Secondary (Science), Higher Secondary (Computer) (CBSE English Medium), For Pre Primary Rs.29,000/- against Rs.34,000/-, For Primary Section Std. 1 to 2 Rs.30,000/- against Rs.35800/-, For Primary Section Std. 3 to 5 Rs.31,500/- against Rs.37,200/-, For Primary Section Std. 6 to 8 Rs.32,500/- against Rs.38,500/-, For Secondary Section Std. 9 to 10 Rs.37,000/- against Rs.44,100/-, For Higher Secondary Section (Commerce) Std. 11 to 12 Rs.40,500/- against Rs.48,200/-, For Higher Secondary Section (Science) Std. 11 to 12 Rs.44,000/- against Rs.52,200/- and For Higher Secondary Section (Computer) Std. 11 to 12 Rs.46,500/- against Rs.55,000/- for the academic year : 2021-22.

2. On receipt of said order, the school has raised its objection while his letter dated 15.12.2021 and also School representative Shri Kamlesh R. Agrawal (Hon. Sec.), Shri Trilokchand Agrawal (Treasurer), Shri Prashant G. Jani (Office Superintendent) and Shri Rajesh R. Khubchandani (Asst. Office Superintendent) of the school Present and also additional submission submitted on dated 02.02.2022. stating there in that the provisional fee fixed by the committee for the academic year : 2021-22 is not satisfactory and very less than the expenditure of per students.
3. While going through the income and expenditure audit report of the school for the year ending 31st March'2021 the total expense of the school as per the account statement comes to Rs. 7,37,01,061/- out of that the income approx Rs. 5,20,00,000/-, So as per the above audited provisional statement of the school deficit loss comes to approx Rs. 2,00,00,000/- after minutely verify the above statement the depreciation amount, the gratuity provision amount, miscellaneous expenses, leave encashment expenses are disallowable expense but considering the genuine expenses of Rs. 55,68,496/- of increment and D.A. as per the 7th pay commission are found allowable expenses along with pay and allowances of the A.Y : 2020-21 Rs. 93,54,792/- as per the 7th pay commission, the committee agreed to give rise in above fee structure on the part of school management and regarding give implement of 7th pay structure to the teacher's and staff of the school. and considering the quality of education and economical devotion and contribution by the trustee of the school for dispense the quality standard of education of each student, the Following final fee

structure determined by the FRC for the academic year : 2021-22 which are as under

- You are further directed that any excess fees charged from the students over and above the above mentioned ceiling shall have to be refunded to the students.

Terms and conditions:

- 1 The school is not permitted to collect fees more than the final fees determined for the academic year : 2021-22.
- 2 The school is permitted to collect the fees for the academic year 2022-23 and 2023-24 by adding 5% increase in the final fees determined by the committee for the academic year 2021-22. (Subject to in future any Government Resolution passed by the Education Department regarding the declared any ceiling limit of Fee Structure due to Covid – 19 Situation.) Which is binding to the School on and above the order of the FRC.
- 3 It is further made clear that the School is not permitted to collect fees under any head other than the head of tuition fees, term fees as permitted and admission fees of 1 month only in case of new admission and thereby causing any extra

burden on the students. However, total of all these fees should not exceed the final fees determined by the committee.

- 4 It is also made clear that the School should either return the excess fees collected by the School for the year 2021-22 or give adjustment thereof, in the remaining installments of fees of 2021-22.
- 5 Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 6 If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application before the Fee Revision Committee along with challan of Rs.10,000/- by way of filing fees.
- 7 The School is directed to place the final order determining the final fees on its notice board as well as its website respectively in Gujarati and English.
